Sir/Madam,

With reference to your Online application No. **SL-00318-1920** on the subject cited above and the inspection of the school conducted by the Committee on 14/12/2019, I am to inform you that on perusal Inspection Report the following deficiencies have been observed by the Board: -

1. That school is required to submit rectified land certificate for 6131.20 sq. mtr. plot of land along with an affidavit sworn-in before 1st Class Magistrate that all facilities and playground are available on 6131.20 sq. mtr. plot, and all classes are running only this plot as school qualifies minimum land condition on this plot, and school shall not use 2165.15sq. mtr. of plot of land for any purpose in future related to CBSE activities, as this plot [i.e. 2165.15sq. mtr.] is located at 5 meters distance from the main plot measuring 6131.20 sq. mtr. of land, where school is running.
2. Complete video of above plot , along with a clear ariel view of entire school campus i.e. school building and playground on the said plot of land of 6131.20 sq. mtr.

In view of the above deficiencies, the application of the school cannot be processed further. Therefore, you are required to remove all the above deficiencies in one go and submit the compliance report with supporting documentary evidence within a period of 30 days.

It may be ensured that all the documents forwarded to Board must be signed by the Manager and Principal of the school.

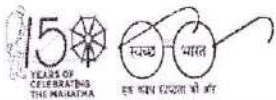
